

TERMS AND CONDITIONS FOR SAFARICOM ETHIOPIA HULEGEB SPONSORED MOBILE DATA

Welcome to Safaricom

The following terms and conditions apply to the Safaricom HULEGEB Sponsored Mobile Data (“HULEGEB Data”). By purchasing and using HULEGEB Data, it means You have read, understood, and accepted the terms and conditions set out herein.

1. Definitions:

- 1.1 “Customer” means a registered physical person, business, company, and any organization including but not limited to government entities, embassies, and Non-Governmental Organizations.
- 1.2 “Safaricom” means Safaricom Telecommunications Ethiopia PLC.
- 1.3 “Service” or “HULEGEB Data” means a sponsored data browsing service for customers while they access HULEGEB sites and other specified digital Apps using the Safaricom network.
- 1.4 "HULEGEB" means an Online Solution PLC that has partnered with Safaricom to provide sponsored data browsing to customers while accessing HULEGEB sites and other specified digital Apps.

2. Service and Eligibility

- 2.1 This is an exclusive product and shall be applicable specifically for HULEGEB and will only be applicable for HULEGEB shared sites and apps.
- 2.2 The service will be provided sponsored by HULEGEB for customers to access for free while accessing HULEGEB sites and other specified digital Apps
- 2.3 Customers must utilize the following URLs or IP addresses to access the free browsing experience.

- 2.4 Customers can access the sites without restrictions on the amount of browsing or repeated time of usage.
- 2.5 Customers shall be on the Safaricom network registered under enterprise or consumer business registered either for pre-pay or post-pay models
- 2.6 Customer's free data browsing will have priority of consumption over any other data bundle
- 2.7 Customers shall not use the sponsored data for roaming purposes.
- 2.8 The service may be changed, amended, or terminated based on any business agreements or understandings reached between Safaricom and HULEGEB.

3. Privacy

- 3.1 Safaricom shall protect and keep your personal information and communication private and shall not disclose it to any unauthorized persons.
- 3.2 Safaricom shall also only process your information in accordance with the law.
