

# REQUEST FOR EXPRESSION OF INTEREST (EOI) FOR THE PROVISION OF SOURCING CATEGORY MANAGEMENT TRAINING

- No prices should be provided with this EOI.
- The receipt of a response shall not bind Safaricom Ethiopia to any contractual agreements with the prospective bidder. Such arrangements shall only come in place once a tender process has been completed and an award issued to a successful bidder after technical and commercial evaluation.
- Any costs associated with preparing and submitting the response to the EOI shall be borne by the EOI respondent.
